CAR VIN PLATE REGISTRATION

All BriSCA Micro F2 Stock Cars must have an official VIN plate which must be registered with BriSCA F2. The VIN plate is registered to the licenced driver using the car. The VIN plate is located centrally on front of chassis between front bumper bolt holes on vertical face.
